

Privacy Addendum for the Systemic Investing Summit 2026 (Rio de Janeiro, Brazil)

The Systemic Investing Initiative ("we" or "us"), also known as the TransCap Initiative, is a non-profit association based in Zurich, Switzerland, with the enterprise identification number (UID) CHE-244.215.765.

Event Platform

Registration and Event management are handled through **Cvent, Inc.**, which processes participant data on our behalf. Please also see the <u>Cvent Global Privacy Policy</u>.

Additional Data Collected for this Event

Depending on your registration choices, we may gather:

- Badge name (if different from your legal name)
- Organization address and VAT number (for invoicing)
- Preferred language and audience group
- LinkedIn profile (optional)
- Dietary preferences or restrictions
- Childcare needs for the Event
- Attendance choice for the Opening Event
- Profile visibility settings, including on the Event "Social Network Map"
- · Ideas submitted for the Event agenda, including the input you could offer
- Confirmation of acceptance of the Event's Code of Conduct and Terms & Conditions



Use of This Data

This data is used solely for delivering Event services (such as registration, payment, access, personalization, networking, and program design) and for complying with applicable legal requirements.

Legal Bases for Processing

Depending on the context, we rely on these legal grounds:

- Contractual necessity to provide registration, ticketing, payment, and participation services.
- Legal obligations to comply with tax, accounting, and regulatory requirements.
- **Legitimate interests** to ensure Event safety, efficient administration, and participant engagement.
- **Consent** for optional features (e.g., networking tools, media use, future communications).

International Data Transfers

Cvent and other service providers may transfer your personal data to countries outside Switzerland, the EU/EEA, or Brazil (including the United States). When such transfers occur, we ensure appropriate safeguards are in place, such as **Standard Contractual Clauses** (**SCCs**) or other mechanisms approved under the GDPR and LGPD.

Data Retention

- Registration and payment data: retained for up to 10 years to comply with Swiss tax and accounting laws.
- Event participation data: kept for up to 2 years after the Event for reporting and follow-up purposes.
- Marketing communications: stored until you withdraw your consent.
- Optional features (e.g., Social Map, LinkedIn): kept only as long as the feature remains active or until you deactivate it.

Your Rights

Under applicable data protection laws, including the GDPR, Swiss law, and Brazil's LGPD, you have the right to:

- Access your personal data.
- Request correction or deletion.
- Restrict or object to processing.
- Request data portability.



- Withdraw consent at any time (without affecting prior lawful processing).
- File a complaint with a supervisory authority, including the **Autoridade Nacional de Proteção de Dados (ANPD)** in Brazil.
